In front of the undersigned Officers and Agents of the Judiciary Police Major Marshal Paolo CAPPELLETTI and Appuntato Scelto Flavio SALZERI, both effective at the ROS with employment at the Carabinieri Anti-Crime Section of Florence, there is Mr. BEVILACQUA Giuseppe, in the indicated heading, which exonerated in the context of the delegated activity carried out in the context of Criminal Proceedings 879/2018 R.G.N.R. mod. 45 – Public Prosecutor's Office at the Court of Florence – (Bevilacqua case TN) on request reports the following:

Mr. BEVILACQUA Giuseppe has been told by us that some journalistic articles that bring his person closer to the events related to the events of the so called "monster of Florence" have been published in recent days asking him if he is aware of it. He replies that he is not aware of it. At the same time, leafing through the newspaper *La Nazione*, he finds one of the articles indicated by us on page 13 of the chronicle.

Mr. BEVILACQUA became aware of the fact, contacted his lawyer Paolo Russo and subsequently attorney Elena BENUCCI both from Florence who spoke on the phone with Major Marshal CAPPELLETTI saying that a warning is underway against AMICONE Francesco because of some of his questionable behavior towards Mr. BEVILACQUA.

Question: Can you briefly indicate chronologically your work history in Italy?

Answer

I came to Italy in 1964 (1963, according to his OMPF TN) from the Fort Dix New Jersey Infantry School Barracks. Initially I was a Simple Marshal (translation of "sergeant" by Bevilacqua TN) responsible for the inventory and control of materials at the Livorno barracks. In 1968 (in 1966, according to his OMPF TN) I returned to the United States of America and later sent to serve in Vietnam with the rank of Major Marshal. At the end of 1969 (at the beginning, according to his OMPF TN) I returned to the United States of America where I stayed until 1970/71, when I returned to Europe and then to Italy. In Italy I was Major Marshal in charge at the Logistics Command at Camp Darby in Pisa.

In 1974 I retired and was appointed Deputy Director and then, in 1978 (in 1977, according to ABMC TN), Director of the American Military Cemetery of Falciani. In 1979 (in 1989, according to ABMC TN) I was appointed Director of the American Military Cemetery of Neptune where I remained until 2010. After 2010 I returned to the province of Florence where I currently live in the municipality of Sesto Fiorentino.

Question

During your stay in Florence and its surroundings, did you get to know some subjects considered to be linked to the events of the so-called "Monster of Florence"?

Answer

During my stay in Falciani I got to know Pietro PACCIANI (he had told the court he did not know him in 1994 TN) as he used to come along the fence to hunt animals and I lived inside the American Military Cemetery of Falciani; other times I happened to meet him at the Bar of the Scopeti (nearby the 1985 crime scene in San Casciano Val di Pesa TN).

Question

With regard to the double murder of the couple at Scopeti on September 8, 1985, for which he was already acquitted at the hearing on June 7, 1994, can you briefly tell us the facts to your knowledge?

Answer

The couple of French youngsters had camped in an area along the road toward Sant'Andrea, behind the American Military Cemetery in Falciani, where nearby there were signs that warned about the danger of aggression by the so-called Monster of Florence. I remember that the day before the murder I saw the girl sunbathing in a black swimsuit and the night of the murder my two dogs, giant boxer breed, began to bark seemingly for no reason, so much so that I had to tie them in chains. I have never spoken to the couple French and I have not noticed anything else.

Question

With regard to the journalistic articles published in recent days that bring your person closer to the events related to the events of the so-called "monster of Florence", do you know the freelance journalist Francesco AMICONE?

Answer

I confirm that I know Francesco AMICONE. I met him in the spring of 2016 (error - 2017 TN) when he showed up at my house presenting himself as a book writer and that he had my name and my residence from the American Consulate in Milan (ABMC officer Melanie Resto's email says he gave me his phone number through her TN). He told me that he was interested in writing a book about my life as Director of the American Military Cemetery in Falciani and as a soldier (in the email sent to Resto it is written I need the consultation of Bevilacqua for a bio of a military policeman who operated in California during the Vietnam war TN). From that moment on we met about 4 times (6 times TN) always at my house (also in Falciani TN) after phone calls. Initially he asked me to tell him about my life but I immediately noticed that he was inclined to emphasize the story by adding details that did not correspond to the truth. For this reason I invited him not to come to my house anymore and I told him not to publish anything I had told him (phone data says that, on September 12, 2017, Bevilacqua consulted a penal lawyer of my acquaintance). Pursuant his insistence (a request of evidence by me sent in May 2018 TN) I had to turn to the lawyer Paolo RUSSO of Florence to warn him. In this regard, I give you the photostatic copy of a written letter dated May 5, 2018 that I have

received by Mr. AMICONE Francesco, whose original I have already delivered to Paolo RUSSO (this letter delivered on May 7 asked a proof of Bevilacqua's identity/guilty in the Zodiac case. A warning by lawyer Russo was mailed and never delivered to me on May 24, 2018, just after the publication of my first articles on the Zodiac-Monster connection on tempi.it that Bevilacqua has just said he did not know the existence of TN).

Question

Can you tell me your exact city of birth in the United States of America and if you have ever been to California and more precisely in Riverside?

Answer

I was born in the municipality of Totowa Borough in the state of New Jersey. I only passed through California when I had to go to Vietnam to serve in the military (in 1968-1969, according to his OMPF TN).

Other times I have been to California with the family on vacation but only for short periods. I don't remember ever being in Riverside in California but I point out that in the United States of America there are more places called Riverside which means "by the river".

This hearing took place without any deprivation of freedom of the personal sphere, that is, without any coercive or coercive mode. In no case was the head induced in the answers altering the re-enactment of memories.

In view of the age of Mr. BEVILACQUA Giuseppe and his state of apprehension, the drafting of this act was attended by the following persons:
